<u>SCHEDULE 1</u> – ANY BUSINESS TANGIBLE PERSONAL PROPERTY INCLUDING EQUIPMENT, FURNITURE, FIXTURES, BOOKS, OFFICE AND BUSINESS MACHINES, SHOP TOOLS AND COMPUTERS USED IN ANY BUSINESS OR OCCUPATION MUST BE LISTED BY THE ORIGINAL COST.

<u>SCHEDULE 2</u> – ONLY THOSE TAXPAYERS ENGAGED IN MANUFACTURING, MINING, RADIO OR TELEVISION BROADCASTING, DAIRY, DRY CLEANING OR THE LAUNDRY BUSINESS MUST REPORT MACHINERY AND TOOLS BY LISTING ORIGINAL COST.

SCHEDULE 4 – LIST INVENTORY OF STOCK ON HAND AS OF JANUARY 1, 2018. THIS FIGURE MUST BE THE SAME AS REPORTED TO THE INTERNAL REVENUE SERVICE FOR 2017 CORPORATE RETURN LINE 6 OF SCHEDULE A OR LINE 37 OF THE 1040 SCHEDULE C.

IF YOU ARE FILING AN EXTENSION FOR YOUR INCOME TAXES, PLEASE COMPLETE THIS FORM USING THE INFORMATION YOU HAVE FROM LAST YEARS RETURN. IF DOING THIS, PLEASE INDICATE BY CHECKING THE BOXES ON THE RETURN "FILING INCOME TAX EXTENSION".
- *** IF THE COST AMOUNTS REPORTED ON THE RETURN VARY FROM PRIOR YEAR AMOUNTS, PLEASE PROVIDE AN EXPLANATION OF THE DISCREPANCY.

THE TAX AMOUNT IS BASED ON THE ASSESSED VALUE OF THE BUSINESS TANGIBLE PERSONAL PROPERTY LOCATED IN TAZEWELL COUNTY ON JANUARY 1.
- *** IF YOU NEED ADDITIONAL TIME TO FILE, YOU CAN REQUEST A 30 DAY EXTENSION BY COMPLETING THE REQUEST FOR EXTENSION FORM. THIS FORM CAN BE OBTAINED IN THE COMMISSIONER OF THE REVENUE OFFICE OR BY VISTING OUR WEBSITE.
